### Science diplomacy in the context of regionalization of international relations/ Научная дипломатия в контексте регионализации международных отношений

The purpose of this research is to reveal the place of science diplomacy in the context of regionalization. The relevance of the topic is related with the tendencies for emergence of new diplomacy types, as well as the conceptualization and regionalization trend. This study considers the experience of science diplomacy implementation by several international organizations and allows for investigating existing mechanisms and institutions of this process. This research studies the concept, dimensions and forms of science diplomacy. Further, a political and legal analysis of certain international associations' (the EU, the SCO, the ASEAN) documents is undertaken. The results of some multilateral science diplomacy cases are considered. The author attempts to formulate the significance of these results and the practice of science diplomacy itself in the framework of the regionalization process.

## Longing and disorientation in experimental modern Chinese prose: Gao Xingjian and Su Tong/ Тоска и растерянность в авангардистской современной китайской прозе: Гао Синцзянь и Су Тун

This presentation examines the key themes and idiolect in the work of Gao Xingjian, a crucial writer in modern Chinese literature. I begin by discussing the importance of Gao Xingjian's peregrinations to his work, in which returns to his childhood village are described poignantly. Finally, I consider the importance of onomatopoeia in his work, suggesting that this linguistic feature is significant, conveying the emptiness that the narrator experiences when considering his childhood.

The introduction of kaizen methods into the American corporate culture: a case study of Toyota factories in the USA/ Внедрение методов кайдзен в американскую корпоративную культуру на примере заводов Toyota в США

During the pandemic, many companies found themselves in a situation of extreme uncertainty. At such critical times, stability within a company plays a decisive role. Toyota has become a striking example of how to work with its own staff by opening new prospects for business scaling. With the help of a kaizen methodology, each employee is involved in production processes through the maximum realization of human potential. However, the American approach to personnel policy

implies that employees can be "hunted" with profitable offers and laid off depending on market conditions. Toyota's corporate culture, on the other hand, postulates a partnership between an employer and a subordinate and does not give up surplus labor in crises. This research shows what fundamental things the two approaches have in common and how they differ, how a kaizen methodology was integrated into the American corporate culture of hiring and how this blend promoted great success even during the pandemic.

Social networks as a factor in regional administration's accessibility for local population/ Социальные сети как фактор доступности региональной администрации для местного населения

The emergence of digital technologies in the life of society requires a professional presence of government bodies and civil servants on the Internet space. Moreover, social networks are a very effective tool for forming the image of a politician on the Internet. The relevance of the topic and the study as a whole are due to the widespread penetration of social networks into the life of society. The purpose of the research is to reveal the prospects for the use of social networks in the professional activities of civil servants. In this study, several media profiles of heads of Russian regions are analyzed, and the results make it possible to conclude that thanks to the Internet accessibility of public offices specific local issues were resolved.

Authorial anthropology as a leading practice of modern fine art: a case study of V. Kandinsky/ Авторская антропология как ведущая практика современного изобразительного искусства на примере творчества В. Кандинского

The concept of authorial anthropology came into being in the period of postmodernism where the role of a creator is blurred and is to fit such criteria as the personification of creation (authorial) and the essence of his personal character (anthropology). The aim of the study is to consider the creative activities of V. Kandinsky, who is considered as one of the pioneers of abstraction in western art. The art of the 20th century is primarily associated with Kandinsky, master of abstract Impressionism. Kandinsky's language evokes diverse and complex feelings and associations in the viewer's imagination, his own understanding of the dramatic collisions and conflicts of life and of inevitable conflict between the individual and society. His idea of absolute synthesis of all arts changed not only painting but music, cinema, dance, architecture, and design.

The ideological side of globalization: the phenomenon of globalism as an essential component of the political philosophy of Alexander Panarin and Ulrich Beck/ Идеологическая сторона глобализации: феномен глобализма как сущностная составляющая политической философии Александра Панарина и Ульриха Бека

Globalization has created a world in which everything tends to homogeneity, unitarity – universalization. Westernization, in turn, led to the creation of a global model of the world from a western point of view. A number of authors, including Alexander Panarin and Ulrich Beck, closely link westernization, understood as globalism, and globalization. However, globalization is not only a phenomenon, but also a concept. Thus, it should be noted that "risk" (in Beck's narrative) and "globalization" are actually sides of the same phenomenon. Both of them challenge and overturn the role of governments, on the one hand, and the role of various social actors, on the other hand.

The aim of the study is to compare the ideas of the two scholars in treating the 'society of risk' concept.

The dispute between Charles Perrault and Nicolas Boileau "Old and New" about contemporary literature: a critical analysis/ Диспут между Шарль Перро и Никола Буало «Старое и новое» о современной литературе: критический анализ

This research draws on the famous dispute between Charles Perrault, who argued that the works created by 17<sup>th</sup>-century authors to the glory of King and Church are necessarily superior to anything produced in the past centuries, and Nicolas Boileau, who held that literary creation has its roots in the fair appreciation of the heritage of antiquity. The study tries to consider this issue from a philosophical point of view maintaining that the ideas we have are directly related to the time in which we live.

The perception of philosophy by young people today: a case study of the evolution of students' ideas (Faculty of Philosophy, Moscow State University)/ Восприятие философии молодыми людьми сегодня на примере эволюции представлений студентов философского факультета МГУ

Students who have chosen to study philosophy are familiar with a widespread, deeply skeptical attitude to philosophy as a future occupation. They find it difficult to relate abstract philosophical ideas to real life problems. At the same time, they understand that it is philosophical attitude to acute problems that helps to find a way to solve them, which associates the study of philosophy with the acquisition of some kind of superiority. The aim of the study is to identify to what extent, if any, students' perception of philosophy changes as they become familiar with the main trends of the subject. The study analyzes the answers of junior and senior students of the MSU Faculty of Philosophy to such key questions as: What is the place and role of philosophy and philosophers in our society? What is their future? Who can be called a modern philosopher? The study considers the stereotypical ideas and false expectations of amateurs, as well as traces the transformation of the identity, motivations and worldview of philosophy students as they enter the professional community.

The importance of Chaadaev's ideas in *Philosophical letters* nowadays/ Актуальность идей Чаадаева в «Философическом письме» в наше время

The Russian idea as a phenomenon and concept has been a central point in the history of Russian philosophy. All Russian outstanding writers and philosophers have attempted to work out and develop the main principles of the Russian idea. Chaadaev is one of the founders of the Russian

philosophical tradition. His name is closely associated with the fact that the center of philosophical thought was transformed from Europe to Russia. The study attempts to emphasize the importance of his philosophical ideas now and to define the extent of Chaadaev's influence on Russia's political development particularly against the background of the recent events on the international arena.

Deep pessimism and socio-political criticism of contemporary Western society in Michel Houellebecq's novels/ Глубокий пессимизм и критика социально-политических установок Запада в романах Мишеля Уэльбека

Michel Houellebecq is a modern French writer, poet and essayist. Most of his works are united by the problems of free love, secularization, the cult of consumption and other phenomena that have prevailed in Western Europe and France since the second half of the 20th century. This study focuses on the idea how Houellebecq tries to predict the future on the basis of the past, in particular his appeal to retain spiritual values that have been accumulated. The novels encourage readers to engage in philosophical "dialogues" and help them to develop their critical thinking about the most topical issues of contemporary life.

Protecting native languages of the peoples of Russia as the basis for cross-cultural harmony/ Сохранение национальных языков народов России как основа межнационального согласия

Russia is a multi-ethnic state, with people of about 193 nationalities living in the country and speaking approximately 277 languages and dialects. The statistics show that various factors such as urban relocation may lead to the disappearance of indigenous languages of the peoples of Russia. As a result, small-numbered nations begin to forget their culture, beliefs and history, which facilitates complete assimilation with the predominant nation. This study raises an important issue about the necessity to protect native languages. By providing a large number of examples, the research underlies the importance of a good knowledge of the Russian language as the state language as well as the maintenance of native languages, considering it as one of the main conditions for ensuring interethnic harmony and developing the spiritual community of the country's peoples.

An analysis of ostensive definitions in *Philosophical investigations* by L. Wittgenstein/ Анализ остенсивных определений в «Философских исследованиях» Л. Витгенштейна The current study examines the issue of the correlation between predicates and their meanings. Many philosophers of language and mind (L. Wittgenstein and others) devoted their research to clarifying what the meaning of a predicate was but fewer thinkers studied how a predicate was connected to its meanings. In language, predicates are represented by the words of relationships

and the words of properties. Thus, the main hypothesis of this research is that there are special gestures for predicates of properties and predicates of relationships. The study is aimed at analyzing and understanding how meanings of predicates exist: whether they are real or simply mental constructions.

The research focuses on analyzing cinematic techniques in terms of their influence on spectators. Filming is known to involve collaborative interactions among over one hundred people and go through particular stages. Not only does it make a film making process complex but a successful outcome is not guaranteed and depends on a wide range of factors. The study examines current trends and categories of techniques typical of different popular genres in the film industry, and discusses the way they affect spectators since the main aim of any film is to keep the audience engaged.

The study deals with the problem of endangered languages and is devoted to the case of the Buryat language. Obviously, with globalization having long-lasting implications, there is a threat of language extinction which means the loss of the nation's culture, its values and traditions. In 2005, the Buryat language was included in the Red Book of Endangered Languages by UNESCO. Besides, according to Rosstat, the Buryat nation is among the three nationalities with the lowest native language proficiency. Nowadays, there is a clear trend, namely: it is grandparents who speak the language for the most part, whereas parents only understand it, but their children do not even understand the language. The research conducted among the youth of the Buryat origin has confirmed the alarming tendency.

The study looks at the activities of Russian merchants such as the Shchukins and Morozovs who tried to get Russian people acquainted with contemporary painting arranging art exhibitions. A particular attention is paid to the fact that they were able to find real works of artists and opted for the artistically valuable paintings of past and the then masters. Their efforts have exerted a seminal influence on the development of art.

In this research, I demonstrate that the analysis supporting the concept of "Theater of Cruelty" provides a framework with which we can understand Artaud's core belief and get closer to understanding the meaning of theater. The aim of this study is to answer how theatrical cruelty is connected with humanistic goals and how it can help us live in peace. The research is based on Artaud's collection of articles "Theater and its Double", Maksimov's book "Introduction to Antonin Artaud's system" and Mamardashvili's article "Antonin Artaud's Metaphysics".

## Communication problems of the modern world through the works of Herbert Marshall McLuhan/ Коммуникационные проблемы современного мира на основе работ Герберта Маршалла Маклюэна

In the modern world, communication has been divided into an incredible variety of parts. Now for us communication is not only a way of transmitting information, but also a huge world opened to research in the human sciences. Marshall McLuhan is one of the main researchers of the world of communication. His ideas are multifaceted and interesting, but at the same time relevant and practical. He coined the expression "the medium is the message" as well as the term *global village*. He thought that the visual, individualistic print culture would soon be brought to an end by what he called "electronic interdependence" and electronic media will replace visual culture with aural/oral culture. In this new age, humankind would move from individualism and fragmentation to a collective identity, which he called a *global village*. That is why, in order to analyze and identify the problems of modern communication, which is what this work is dedicated to, the choice of the works of this researcher is the most justified.

### Linguistic and cultural difficulties in translating advertisements/ Лингвистические и культурологические трудности перевода рекламы

The aim of the study is to analyze numerous linguistic and cultural difficulties that arise in translating advertising. The ultimate challenge for any translator is to preserve as much of this complex meaning structure in their translation as possible. Translating culture-specific elements in a text is always a challenge. Some well-established techniques for overcoming these challenges are discussed in this talk. It is particularly difficult to translate proverbs, popular sayings and winged phrases because they are so unique and culture-specific that they can only be rendered by a word-for-word translation or paraphrase or omitted altogether. The study gives some examples of successful solutions to these difficult tasks.

Particular attention is given to the following methods: "using slogans", "opinions of authorities", "same as all", "emphasis on simplicity and speed of getting effect", "biding or substitution", "selective usage of information". The idea is to get an understanding of how daily advertisements manipulate people's consciousness and psyche.

Overcoming the language barrier: an analysis of Michele Berdy's book *The Russian Word's Worth*/ Как преодолеть языковой барьер: анализ книги Мишель Берди «Лингво-культурологический комментарий русской лексики»

The language barrier is one of the most important humanitarian problems of our time. With the development of international communication, this issue is gaining relevance. This research is based on a number of articles written by Michele Berdy, an American journalist who has contributed to the newspaper The Moscow Times for the last 20 years. In 2010 she published a book *The Russian Word's Worth* where she gathered vivid examples of difficulties a translator faces trying to convey the meaning of Russian words. Her commentaries and ways of translating and interpreting Russian new words, idioms and proverbs help foreigners to successfully overcome the language barrier and prove opportunities for understanding our life and culture better. A few examples from the book will help to see how one can solve translation difficulties.

To reach a global audience, both local and international companies should take into account cultural background of their target audience. The role of advertising in a crisis: a case study of small companies/ Роль рекламы в условиях кризиса на примере небольших компаний

In the midst of a crisis, many companies reduce production, reduce the price list, lay off employees, save literally everything to keep the business for a sufficient amount of time. The advertising budget is being reduced to a greater extent: some companies reduce their advertising activity almost completely, breaking off relations with advertising agencies, classifying this area as optional. The aim of the study is to show that during a crisis, the "motive" forces of advertising do not decrease at all, on the contrary: for many small companies, it becomes the lifeline that allows "keeping the company afloat". He gave the first definition of the term *bullying* – "the kind of violence suggesting the aggressive prosecution one of the members of the team". The present study looks at different types of bullying: physical, verbal, social-psychological, and cyber bullying. It also draws on the work of Anna Kuznetsova called "What is bullying?" According to the author, 55 per cent of children in Russian educational institutions are bullied; 39 per cent of them preferred to remain silent about what happened. The present research looks at typical signs of bullying: difficulty in socializing, lower academic performance, difficulty in finding long-term relationships, and body image issues. The author tries to give some advice about how to recognize signs and signals of bullying.

The relevance of the topic is determined by the modern theoretical trends in science, namely, research in the role of rhetorical practices in scientific communication.

### Contemporary political aspects of separatism in the USA/ Современные политические аспекты сепаратизма в США

This talk analyzes the preconditions for separatism in the United States that have been aggravated by progressing social problems stemming from high social inequalities, unresolved ethnic and racial conflicts. The study suggests that the easy availability of weapons to ordinary civilians created the preconditions for resolving incipient conflicts through armed skirmishes, which in general are already happening on a small scale. The fact that there is no real consolidated ethnic groups within the generally white society (which is historically conditioned) strengthens the ground in the US policy for inter-ethnic conflicts. The American nation has not yet succeeded in creating one single united whole. In this situation, the build-up of unresolved contradictions creates an accumulative effect. Thus, since the mid-20th century, the acuteness of this problem has acquired new colors.

Mordvins or Teryukhans – this is how researchers of folk life began to name a small group of Finno-Ugric indigenous population of the Nizhny Novgorod district at the end of the 19th century. The Nizhny Novgorod province – about 25,000 people – has a compact area of settlement with a center in the Teryushevskaya volost (the modern territory of Dalnekonstantinovsky district of the Nizhny Novgorod region). In the middle of the 19th century I.P. Melnikov (A. Melnikov-Pechersky), drew the attention of researchers to the ethnic group of Teryukhans for the first time in a number of his articles on the Nizhny Novgorod Mordovians. The interest was caused by the fact that, despite the almost complete loss of the language and the perfect merger with the Russians in the field of economic life, the Teryukhans retained their original national costume, ritual culture and self-consciousness of Teryukhans as it was at the end of the 19th century. This ethnic group is the subject of the present research, in which the author dwells in detail on peculiarities and unique qualities of these people.

Archetypes of fictional Russian characters in Western comics culture: the political aspect/ Архетипы выдуманных русских персонажей в западной комикс-культуре: политический аспект

Modern western comics have their roots deep in history. This, especially in superhero plots, inspired authors to include characters who would reflect the perception of key political actors and roles of certain countries in them. One of the most typical scenarios of such reception may be defined as the "Russian track", which gave us many images that are still part of active political and cultural discourse. Therefore, this study identifies and describes five key archetypes used to facilitate Russia- (or USSR-) originating characters. Among them are "Scientist" – Red Dynamo, Mikhail Ursus (Marvel Comics); "Mafia member" – Rhino (Marvel Comics), Little Nina (Dynamite Publishing); "Special service agent" – KGBeast (DC Comics), Chameleon (Marvel Comics); "Political fugitive" – Valentina Vostok (DC Comics), Black Widow (Marvel Comics); and "Loyal citizen" – Red Guardian (Marvel Comics), Officer Smirnoff (Dargo). Using this approach allows for inquiring into the nature of how major stereotypes are spread among general public and what image of Russia they present. Moreover, it shows the key concepts and cognitive constructs that can be used in political communication in terms of Russia-oriented discourse.

Faced with the largest since World War 2 refugee crisis due to the dramatic events in the Middle East, the European Union countries had to accept the unprecedented calls. In 2015, the Syrian Civil War, the Iraq War and War in Afghanistan were the main reasons that made about 1.3 million people request the asylum. Countries such as France, Germany, Italy and Sweden granted almost two-thirds of the applicants the protection status. This required the development of the updated strategy towards refugees. In 2020, the European Commission came up with a proposal of the new comprehensive approach to migration and asylum policy. However, since February 2022, the situation has taken the different turn, which necessitated the new round of regulation. The stream of refugees from Ukraine brings an array of issues to the hosting countries. Poland, Germany and the Czech Republic are the EU countries that accept the biggest numbers of refugees, and they have to find a way to provide them with adequate assistance and support. This presentation is an analysis of the current European policy towards refugees starting from 2015 until present.

The study aims to analyse the concept of illusion in Marshak's and Carroll's key texts. The phenomenon of childlike reality allows us to talk about the audience of readers – not just agerelated, but also mentality-related. The author provides an account of polysemous word "illusion": illusion as a cultural concept (not a term), an aesthetic experience and an artistic riddle. The results of the investigation show that the concept of illusion can be called a means of intercultural communication – the assertion is based on the analysis of Carroll's *The Lobster Quadrille* and Marshak's translation; translation, in turn, is interpreted as an illusion itself. A conclusion is made on the communicative function of the concept. Thus, the concept of illusion establishes crosscultural links.

### The phenomenon of digital authoritarianism: a case study of Singapore/ Феномен цифрового авторитаризма на примере Сингапура

In recent years, it has become popular to say that the real power belongs to those in possession of the information. Every year, in many countries, we can witness an increasingly stronger government control over citizens' access to information on the Internet. If earlier the development of the Internet and digital technologies was perceived as an opportunity to strengthen democracy and civic participation, today, according to some studies, the opposite process can be observed. The development of digital technologies can also give rise to a phenomenon of digital authoritarianism sometimes defined as being based on manipulation of information through the introduction of elements of artificial intelligence. One of the most striking examples of digital authoritarianism can be seen in Singapore. Singapore's breakthrough away from the third world countries to the group of the most developed countries in the world, accomplished in a very short period of time, cannot but cause admiration. Digital technologies played an important part in this breakthrough. In this talk, we consider how modern technologies affect a political regime using the example of Singapore.

Brexit has been one of the most discussed topics for the past few years. Not only has it influenced economic and social spheres, but also affected cultural relationships between art producers and art consumers. For instance, most of the museums, art galleries, theaters, art spaces used to be funded by the "Creative Europe" programme, which was cancelled due to the current situation. Beside the financial aspect, one more complication came to the fore: art creators lost their privilege of being "visa-free tourists". This problem was not included in the post-Brexit UK-EU trade deal thus strengthening fears within art industry about their future. According to the researchers from the Cambridge Econometrics, Brexit would make a crucial impact on the quantity of workplaces and "27,000 creative jobs could be lost in London". The study is aimed to analyze consequences of

Brexit that have negative influence on the cultural sphere of the country; and look into the issue of whether new post-Brexit politics is going to resolve the above side effects. The research reveals the current post-Brexit situation in the British art society, as well as related financial and social aspects.

In 2014, the Chinese government reached a new level of control over its citizens by launching the Social Credit Score System, which is based on tracking people's behavior using Big Data. Within the framework of this assessment system, the rating of residents of China – a country whose population reaches almost 1.4 billion people – is determined. The goal of the social credit system is to make it easier for people and businesses to make fully informed business decisions. The automated system determines the position of citizens by tracking their social behavior: how and what they spend money on, whether they pay bills regularly, and even how they interact with other people. The system is publicly available to everyone, and a public assessment means "the level of trust of the authorities" to a particular citizen. The research has shown, that despite a quite recent launch of the system, the Chinese government promises to make it nationwide.

### Threats to women's rights in present-day Iran/ Угрозы правам женщин в современном Иране

Wearing a headscarf and closed clothing became mandatory for Iranian women after the Islamic Revolution. Just a few weeks after Khomeini came to power, on March 8, 1979, more than 100,000 women took to the streets of Tehran, protesting against a series of bans that limited their rights. In response, the government lifted some restrictions, promising that wearing the hijab would not be mandatory, and the protests died down. However, a few years later, a law was passed on corporal punishment for women who appeared in public in an inappropriate form. Other bans had also returned, covering a wide range of areas, from education and careers to family life and leisure. Today in Iran, there are mass protests that have acquired the character of political ones. Our talk is analyzes the historical background of women's political protests in Iran. In addition, we present several possible scenarios for the future actions of the women's movement in Iran.

### An analysis of Russian political culture's influence on the electoral behavior of citizens/ Анализ влияния русской политической культуры на электоральное поведение россиян

Electoral culture is an integral part of the political culture of society. It is a relatively new political science category and has not been studied enough yet. This research deals with two main issues. They are (1) the uniqueness of the Russian electoral behavior, focused on the figure of a politician as a national leader, and (2) the increased personification of power as a constant of the native Russian political culture. The author analyzes the behavior of modern Russian voters who are focused on the personality of a candidate or a party leader rather than on objective information about the programs of parties and candidates. That is why the choice of a candidate is primarily determined by the focus on their personality, then (descending) – on the party they represent, and finally – on the possible effectiveness of this party in case of its victory. Of particular importance is that some voters might take into account the opinion of their relatives while making a choice.

The author reflects deeply on interdisciplinary themes covering medicine, genetics, family, love, ethics, and race. Taking "enigma" as the entry point, characters constantly make ethical choices after enigmas and conflicts. Ulitskaya reconstructs the spatio-temporal structure of dream world after the heroine Yelena's illness with a brain text narrative, forming a heterogeneous

space between life and death. This novel adopts a carnivalesque approach, and a series of narrative descriptions that occur in heterogeneous space are the answers and continuations of the spiritual life that the real protagonists have been searching for.

Petrushevskaya. They see the overlap of social problems and characters described in their works. Chinese scholars are especially interested in the similarities and differences in the portrayal of Russian intellectuals in the two writers' works.

One of the most serious is inability to control people's behavior in social nets, which in turn leads to negative social and psychological consequences. Nowadays we witness such a negative phenomenon as online bullying (often referred to as cyberbullying). This is a form of bullying that is carried out through the use of electronic media devices, such as computers, laptops, smartphones, etc. Communication on the network becomes more aggressive, we can come across some curse words, direct insults, and sometimes even threats. All these negatively affect mental and moral state of users. In our research, we analyze the problem of online bullying and suggest some ideas how to do away with socially destructive, aggressive behavior in the media space. Modern Russian youth interest in their country's cultural heritage: on the Russian government policy in this sphere/ О политике российского государства в сфере стимулирования интереса российской молодежи к культурному наследию своей страны

The study presents the results of the study conducted in order to specify the interest of modern youth in the cultural heritage of Russia. For a thorough research, a corresponding questionnaire was developed and more than 100 people were interviewed on it. Also, some features of modern Russian culture were analysed, namely, Russia's entry into the world cultural and information space; predominance of commercial character; decline in interest in literature and theatre; popularization of foreign culture and absence of state ideology. According to the results of the study, the following aspects were revealed: the tools that are most influential in the formation of the attitude of Russian youth to the cultural heritage of their country; the age of people who are least aware of the importance of cultural education; aspects constituting the cultural heritage of Russia. The analysis of the results showed that not all respondents really understand what the cultural heritage of our country is, many of them narrow the definition to one element of culture or even name just specific objects. The family and educational institutions influence the attitude of young people to culture most of all. These facts indicate that it is necessary to raise the level of cultural education by means of family, schools and universities. Furthermore, it was concluded that people who grew up in the 1990s are the least aware of the significance of Russian culture. During the study, the reasons for this fact were revealed. Additionally, the Pushkin card program was analysed. It was introduced in the autumn of 2021. Its goal is to raise a generation of enlightened listeners and viewers, to form the habit of useful leisure. Over the period of the program (12 months), more than 160 thousand tickets were purchased by the Pushkin Card. And it is a great example of cultural popularization in our country.
