Ломоносова успешно прошла XIII Межфакультетская научно-практическая студенческая конференция на английском языке «Гуманитарные проблемы современного общества», посвященная Году педагога и наставника в России. Всего в конференции приняли участие более пятисот человек - студентов, магистрантов, аспирантов и сотрудников гуманитарных факультетов.

Конференция была организована и проведена кафедрой английского языка для гуманитарных факультетов факультета иностранных языков и регионоведения (ФИЯР).

Данный сборник содержит тезисы докладов, охватывающих широкий спектр актуальных на сегодняшний день тем. Все поданные на конференцию заявки сопровождались отзывом научных руководителей или специалистов в соответствующей области. Было сделано около двухсот научных докладов, которые охватывали широкий круг проблем, касающихся научно-исследовательской деятельности студентов и аспирантов.

The doctor's image in Mikhail Bulgakov's short story cycle A Country Doctor's Notebook as a form of authorial presence/ Образ врача в цикле рассказов «Записки юного врача» Михаила Булгакова как форма авторского присутствия

The purpose of this study is to analyze the image of the young doctor in the short story cycle *A country doctor's notebook* by Mikhail Bulgakov. The image of the young doctor is multifaceted and develops dynamically. The hospital in the countryside plays a vital role in his growth: here he not only becomes more professional, but also gains psychological growth. All the aesthetic elements and attitude towards the profession of a doctor that appear in the text are manifestations of the authorial presence, which can be connected to Bulgakov's biography. A comprehensive analysis of historical memories: a case study of Belarus and the Grand Duchy of Lithuania (1236-1795)/ Исследование исторической памяти на примере Беларуси и Великого княжества Литовского (1236-1795)

This research investigates the politics of memory in Belarus, with a particular focus on its historical ties with the Grand Duchy of Lithuania. It delves into how this historical legacy has been instrumental and contested in contemporary Belarusian politics. The research explores various actors involved in the politics of memory, including governmental institutions, civil society organizations, and individual citizens. The theoretical foundations are built upon the evaluation of studies by A. Miller, G. Krasko, D. Anikin, etc. Using Belarusian student books, government officials' statements and official documents of different Belarusian political actors, it analyzes their narratives, discourses, and strategies in preserving or reshaping collective memory related to the Grand Duchy of Lithuania. The study also investigates how these memory dynamics interact with broader political and societal developments, such as nationalism, democratization, and geopolitics. Furthermore, the present study critically assesses the impact of the politics of memory on Belarusian society, focusing on its implications for national identity, cultural heritage, and intergroup relations. It examines the contested nature of memory narratives and the tensions that arise from different interpretations of historical events. In conclusion, this research sheds light on the intricate dynamics of the politics of memory in Belarus, examining the historical ties with the Grand Duchy of Lithuania and their significance in contemporary Belarusian society. It offers valuable insights into the complex interplay between memory, identity, and politics in the region.

Broadcasting cultural values in modern social advertising/ Трансляция культурных ценностей в современной социальной рекламе

The purpose of the research is to reveal the process of broadcasting cultural values in modern social advertising. In the course of the conducted research, the main functions of the advertising slogan were identified. It is noted that a popular linguistic manipulation technique is the use of symbols in the context of social advertising. The structure of the symbol was analyzed using numerous examples. A detailed description of the polycode text was given as one of the most common tools for broadcasting national characteristics and cultural values in social advertising. Using examples from Russian social advertising, various elements of cultural information contained in polycode texts were analyzed. Possible effects of the influence of social advertising on behavior patterns, attitudes, value orientations and physical condition of the individual were also considered.

The art of brinkmanship from a historical perspective: a case study of the USA/ Политика балансирования на грани войны на примере США: исторический анализ

The modern system of international relations periodically sees arising crises, where the parties involved, despite a very real threat of armed confrontation, take deliberate steps towards open conflict, engaging in a risky strategy usually labeled as "brinkmanship". This research, based on theoretical contributions of scholars such as Henry Kissinger, Jeffrey M. Elliot and Ned Lebow, proposes that the historical and modern usage of this practice is enabled by the global geopolitical environment, and lays out a chronological timeline of its development in history and modernity, from its proper emergence during the peak of the Cold War and up to the present "age of madmen".

Analyzing contemporary approaches to macropolitical identity in Russia/ Анализ современных подходов к макрополитической идентичности в России

The research is devoted to the problem of modern Russian macropolitical identity. Despite the fact that more than 30 years have passed since the collapse of the Soviet Union, the issue of forming all-Russian identity is still on a scientific and political agenda. The research examines the correlation between three key narratives that compose the modern macropolitical identity in Russia: the ideas of nation, civilization and patriotism. Methodological foundations of the research include interactionist, cognitive and constructionist approaches to the concept of identity. Furthermore, official documents and the results of sociological research were examined using the method of discourse analysis. It has been revealed that all-Russian collective identity has a hybrid civilizational-national nature, which is due to the history and the features of forming macropolitical identity in the Russian Empire and the Soviet Union along with the crisis context of its origin and development under the conditions of actualizing regional and local levels of political and territorial identification.

Applying AI and Big Data technologies to election campaigns: a case study of the 2015 Nigerian elections and the 2016 US presidential elections/ Применение технологий ИИ

и Big Data на примере выборов в Нигерии (2015) и президентских выборов в США (2016)

The research provides crucial insights into a Cambridge Analytica's data-driven approach to political campaigns which involves data collection, analysis, and the use of Big Data and artificial intelligence. The organization has collected personal data from over 87 million users through the "This is your digital life" app, and gathered a "digital footprint" from users on social media platforms. Cambridge Analytica used the "OCEAN" methodology to categorize users based on psychological profiles and analyzed their political preferences. By using personal and demographic data this approach allows users to influence individuals' opinions and behavior patterns. The organization's involvement in various global political campaigns, including the 2016 US presidential elections and the 2015 Nigerian elections, suggests potential effectiveness of its methods. However, criticism arises from concerns that the data used may not significantly differ from publicly available voter databases, and the user's positions can change over time. The study provides the author's view on potential effectiveness of this data-driven approach.

The interaction between government and business as a driver of Russia's innovative development/ Взаимодействие государства и бизнеса как драйвер инновационного развития России

The development of an innovation sphere should meet not only modern socio-economic challenges but also the actors' requirements of innovation activities that influence economic growth and domestic interests. The purpose of the study is to understand how the interaction of business structures and authorities affects the innovative development of Russia. The modern world is undergoing a large-scale and dramatic change concerning the reshaping of the existing world order. Violence and crimes against civilians were observed during the last decade of the 20th century and criticized by the international community. The study investigates the 2005 high-level UN World Summit meeting, a document drafted and

committed to oversee the principles of the Responsibility to Protect, according to which UN members are supposed to prevent the most serious violations of international human rights and humanitarian law. The document thereby establishes the institute of humanitarian intervention. This research is an attempt to fill the gap in critical understanding of R2P concept in its theoretical and practical application. The research has been drawn on previous studies and historical cases in the field of regulatory amendments to identify the current state of the concept in question.

Personalistic ideas in philosophical and political concepts of P.I. Novgorodtsev and N.A. Berdyaev/ Персоналистические идеи в философско-политических концепциях П.И. Новгородцева и Н.А. Бердяева

The relevance of the present research is largely explained by contemporary debates in the field of social and political philosophy, as well as the global challenges that democracies are facing today. The study confirms the thesis according to which Nikolai Berdyaev and Pavel Novgorodtsev, relying on Christian personalism, consider ensuring individual rights and freedoms as a decisive basis for political activity. Meanwhile, the research highlights some differences in the views of the philosophers. Unlike P. Novgorodtsev, N. Berdyaev believes that human morality and ethics become possible only through human interaction with the Personality of God. In addition, according to Berdyaev, the rule of law is only a temporary phenomenon, since true freedom stands above formal freedom, and the main path to the liberation of the individual should be sought in internal spiritual work. Analyzing international security in the 21st century: a case study of cyber warfare/ Международная безопасность в XXI веке: анализ угроз на примере информационной войны

The 21st century has witnessed the rise of the Information Age, characterized by the unprecedented access to unlimited information for citizens. However, this abundance of information does not inherently guarantee reliability, as individuals often tend to trust unverified sources and unreliable information. Exploiting this vulnerability, publishers of fake news and propaganda have seized the opportunity to disseminate their agendas. Consequently, a new battleground has emerged: cyberspace. It implements digital technology to conduct attacks against individuals, organizations or countries for disruption or sabotage. The main difference between cyber warfare and traditional kinetic conflict is the problem of identifying the perpetrator. This problem poses a pivotal challenge to national sovereignty and security transcending national boundaries and exploiting civilian resources such as the internet, cell-phones, news-publics, etc. To conclude, cyber warfare is a damaging threat in the 21st century. It focuses on digital attacks and breaches. Understanding the characteristics and peculiarities of this threat allows intelligence agencies and the international community to develop appropriate strategies to fight effectively.

A comparative analysis of managing conflicts in different regions of the world: the experience of the UN (a case study of Congo and Syria)/ Сравнительный анализ методов противодействия конфликтам в разных регионах мира: опыт ООН на примере Конго и Сирии

The goal of this comparative analysis is to examine various methods and approaches that the UN uses to resolve conflicts in different regions of the world. Syria and the Democratic Republic of the Congo exemplify the solutions to deep-rooted and complex conflicts, however, the UN approaches to their settlement were significantly different. In Syria, the UN actively used diplomatic negotiations and Security Council resolutions. This approach is based on the principles of peaceful settlement of disputes and non-interference in the internal affairs of States. In the Democratic Republic of the Congo, the UN's approach was different. Here the UN launched a peacekeeping operation and provided humanitarian assistance to the population of the country. This approach is based on the principles of protecting human rights and preventing humanitarian disasters. Comparing these two cases allows us to see various tools and methods that the UN can use for resolving conflicts. This, in turn, opens up new prospects for studying the effectiveness of the UN's actions and the possibilities for improving its work in this direction. This study is necessary for a deeper understanding of the complexities of international relations and mechanisms for managing international conflicts. In addition, it can help to develop new strategies and approaches aimed at preventing and resolving international disputes and conflicts.

Russia recognizes the pressing demands of tackling climate change as one of the greatest contributors to the world's emissions of greenhouse gases and has undertaken substantial initiatives to foster sustainable development and reduce its ecological footprint. This study examines significant Russian government actions, such as the

On 15 October 2023, parliamentary elections to the Sejm and Senate were held in the Republic of Poland with a record turnout of 74.38%. The ruling Law and Justice party won the elections. However, it lost the absolute majority of seats in parliament. The government may now be

formed by a political coalition consisting of the three major opposition forces, provided they can negotiate successfully, hence three main oppositional blocs (Civic Coalition, Third Way and New Left) have very diverse political views. The result of the coalition formation would significantly influence the internal policy and, to a lesser extent, the foreign policy of the Republic of Poland. It may also paralyze the work of the government altogether, in this case re-elections could be called. The study presents several scenarios for coalition formation. However, the elections and active participation of citizens are certain to show the split in Polish society.

Polyglottism effect in the literary narrative (E. Vodolazkin's novel Laurus and its translation into English)/ Эффект полиглоссии в нарративе художественного текста (на примере романа Е. Водолазкина «Лавр» и его перевода на английский язык)

The study examines the polyglottism effect in a literary text, namely in the novel *Laurus* (2014) by Evgeniy Vodolazkin, and translation difficulties which this linguistic device might create. In the paper the mixture of two languages in the narrative is regarded as the "polyglottism effect". In particular, Vodolazkin's text is based on constant diachronic shifts, and Modern Russian and Old Russian, the same language at different stages of its historical development, create the interplay of different epochs. Lexical ahistoricity is used by the author to convey the main message of the novel, ahistoricity of human existence. The translation strategies employed by Lisa Hayden in her English version of *Laurus* are analyzed. Register shifts and diachronic transitions were accurately preserved in Hayden's translation with the help of the Bible language. Culture-specific elements of Medieval Russia and lexical anachronisms were translated using transliteration or descriptive translation.

The author refers to the positive experience of Belgium, where the authorities are most interested in protecting the rights of forcibly exploited women. Using historical and philosophical analysis of these works, the author argues that the use of metaphors has great theoretical implications for Husserl's phenomenology concentrating on two important characteristics: 1) its use allows for the extension of the language of description and thus for the inclusion of new areas of cognition; 2) the use of metaphors provides the opportunity for a preliminary linguistic investigation into the field of research, which facilitates the discovery of the most complex theoretical problems in this area.
